

Terms & Conditions

1 ACCEPTANCE OF TERMS

1.1 Your access to and use of the Pet Happy London web site, ("the web site") is subject exclusively to these Terms and Conditions. You will not use the Web site or services offered by the web site for any purpose that is unlawful or prohibited by these Terms and Conditions.
